Report of the Director

- 1. On November 11, Region III hosted the annual Veterans' Breakfast for regional veterans and their families. Although I could not attend the event this year, it was reported to me that the event was a great success, with over 150 people in attendance. My thanks to all the students and staff members who volunteered for this worthwhile event.
- 2. On December 3, I will be meeting with regional principals to discuss topics of interest, including the new state law that permits CTE students to receive core credits for work done in their Region III programs. Because principals award graduation credits, this is a very important conversation to have.
- 3. On December 11, Adam Provost from CreativeStir will be coming to Region III to meet with the faculty. Adam is the person who we have contracted with to assist with our marketing and recruiting efforts. Adam specializes in social media marketing and tracking. He has also contracted with Maine CTE to rebrand the state CTE image and increase statewide recruiting efforts.
- 4. On November 14, I met with a representative from NewsCenter to start planning a new vignette that will feature Region III on the NewsCenter Works4ME platform. The last time they were here was in 2021, and the video they produced about our school was very well-received. They are very impressed by our school and what we do, so they want to produce another video that will be shown on their newscast in the near future.
- 5. As previously discussed, I will be sending a few students out for Work-Based Learning experiences soon after Christmas break. Several students have been recommended for this opportunity. My next steps will be to meet with the students and their parents to come up with a plan for each student based upon their interests and availability.
